



## ***Thousand Miles Lease & Rental Services Car Rental Agreement***

This Car Rental Agreement (hereinafter referred to as the “Agreement”) is made and entered into as of March 24, 2025, by and between the Owner, Thousand Miles Lease & Rental Services, with an address of Casuarina Estates, St. Philip and the Renter, as outlined on “Declaration Form” (page 6 of this agreement) with an address as noted on the “Declaration Form”.

In this agreement, the Owner and Renter may also be referred to as “Party” in the singular and “Parties” in the plural.

This **Agreement** is subject to the following **Rental Terms and Conditions** *in addition to terms as outlined in Exhibit 1, 2, 3 which forms part of this agreement:*

### ***Rental Vehicle:***

Owner hereby agrees to rent to Renter the following vehicle:

### ***1. Smoking policy***

There is a “No Smoking” policy enforced on all our vehicles. In cases where vehicles are returned with an offensive odour (e.g smoke) or excessive debris in the interior, clients will be charged up to a maximum of \$300 USD for the cost of a professional valet service. Failure to comply will result in this charge.

### ***2. Rental Period***

Owner agrees to rent Vehicle to Renter for the following period (rental period):

Start Date: **March 25, 2025**      End Date: **March 28, 2025**

*The vehicle will be collected the morning following the end date.*

The Parties agree that this Agreement terminates upon the End Date specified above. Notwithstanding anything to the contrary in this Agreement or any Exhibits, the owner may terminate this Agreement prior to the End Date with at least one (1) day notice.

### 3. *Rental Fees*

The Renter hereby agrees to pay the Owner for use of the Vehicle as follows:

#### **Our Rates and how we charge**

Our vehicle hire rates may vary from season to season. Our rates are determined by supply, demand and market conditions. Rates quoted are only guaranteed at the time they are quoted.

**Fuel:** The Renter is required to return the vehicle with the same level of fuel the vehicle was rented with. Failure to comply with the fuel policy will result in a charge of \$75 USD.

Fuel level: Half  Full:

**Deposit:** \$ \_Up to max. \$200 USD\_ Owner shall retain this deposit to be used, in the event of loss of or damage to the Vehicle during the term of this Agreement, to defray fully or partially the cost of necessary repairs or replacement. In the absence of damage or loss, said deposit shall be credited toward payment of the rental fee and any excess shall be returned to the Renter.

#### **Method of payment**

If paid by credit card, I accept that the payment will be charged to my credit card and that any other charges covered and payable under this contract may be added to my credit card charges.

#### **Payment Methods and Restrictions**

- **Full payment for your rental vehicle and any additional fees are due on the day of delivery.**
- We accept payment by Visa, Mastercard, Debit card, Bank Transfer or cash.
- A credit card or cash may be required if a security deposit is needed.
- The excess / deductible on the vehicle is \$1,250 USD but this is only applicable if any damage occurs to the vehicle in excess of this amount.
- We do **not** accept virtual credit cards. The card provider must be a noted driver on the rental vehicle.

#### **Cancellation & No Show**

- A minimum of 48 hours' notice is required for all cancellation bookings. If this process does not occur, a \$100 USD charge will be run on the credit card.
- Overtime fees will apply if you require delivery after our working hours (after 5pm).

**No refunds are issued if the rental dates are adjusted or cancelled once the contract has commenced.**

### 4. *Insurance*

The vehicle is comprehensively insured, including damage to third party vehicles, property and injury. An excess / deductible of \$1,250 USD will be required in the event of an accident and insurance is required. This does **NOT** cover damage to the stereo, interior damage, tyres, rims nor damage to the seats.

### ***Indemnity***

Regardless of insurance coverage, Renter shall fully indemnify the Owner for any loss, damage, and legal actions, including reasonable attorneys' fees that Owner suffers due to Renter's use of Vehicle during the term of this Agreement, including but not limited to, damage to the Vehicle, damage to the property of others, injury to Renter, and injury to others. This provision survives the termination of this Agreement.

### ***5. Owner Warranty***

The Owner represents that to the best of his knowledge and belief that the Vehicle is in sound and safe condition and free of any known faults or defects that would affect its safe operation under normal use.

### ***6. Renter Warranties***

The Renter agrees that Renter will not (a) allow any other person to operate the Vehicle during the period of hire; (b) operate the Vehicle in violation of any laws or for an illegal purpose and that if Renter does, Renter is responsible for all associated, tickets, fines, and fees; (c) use the Vehicle to push or tow another vehicle; (d) use the Vehicle for any race or competition; (e) operate the vehicle in a negligent manner.

### ***7. Age Requirements***

Drivers must be over the age of **25** and under **80** years of age. For drivers over 75 years old, a medical certificate will also be required or copy of submission to the Licensing Authority for License renewal.

### ***8. Extension of hire***

Requests for extension of the hire should be made 24 hours ahead of the return date, while we make every effort to allow extensions they are subject to availability and cannot be guaranteed.

### ***9. Keys and Fobs***

Vehicle keys are NOT waterproof – the client will be fully responsible for the cost of replacement of lost or damaged keys and key fobs.

### ***10. Driving Permits and Additional Drivers***

- Each driver must have held a valid driver’s license for **at least 2 years**. Drivers must produce this license at delivery.
- A local driving permit is necessary by law and is issued at delivery. These permits are **US\$5.00** each and are valid for 2 months. Any driver **not** in possession of a valid Barbados Driving license must purchase one of these permits before you are able to drive in Barbados. [Visitor Permit - Barbados Revenue Authority](#)
- We allow a maximum of **2** drivers per vehicle at no charge except for a Barbados driving permit.

### **IMPORTANT NOTICES**

- Only persons who have completed a contract and been specifically authorized by Thousand Miles Lease & Rental Services can drive this vehicle.
- Exceeding the seating capacity is against the Laws of Barbados and makes the Hirer liable to prosecution under the Motor Vehicle Road Traffic Act.
- If any of these important notices listed above are ignored, the Hirer will be held personally responsible for any claims resulting from any incidences which may occur while the said notices were ignored. Thousand Miles Lease & Rental Services also reserves the right to take the vehicle from the Hirer without any refund.

#### ***11. Speed Limit***

Renter will obey the speed limit for the Vehicle on the roads of Barbados. The speed limit on the ABC highway is 80 km/h and on most other roads, the speed limit is 60km/h. In the city of Bridgetown, the speed limit may vary from 20km/h to 40 km/h on some roads.

#### ***12. General***

This Agreement, including all Exhibit(s), constitutes the entire agreement between the Parties in connection with the subject matter hereof and supersedes all agreements, proposals, representations and other understandings, oral or written, of the Parties and any current or subsequent purchase order(s) provided by Affiliate. No alteration or modification of this Agreement or any Exhibits shall be valid unless made in writing and signed by an authorized Affiliate of each Party. If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect. Any notice or other communication required or permitted hereunder shall be given in writing to the other Party at the address stated above, or at such other address as shall be given by either Party to the other in writing. Any terms of this Agreement which by their nature extend beyond its termination remain in effect until fulfilled and apply to respective successors and rightful assignees.

TERMS OF HIRE**


1. The Hirer understands that during the period of the hire, the vehicle is not to be driven by anyone who has not completed a contract.
2. The Hirer understands that the insurance cover for this vehicle is underwritten by \_\_\_\_\_ and is governed by the laws of Barbados, whose courts shall have exclusive jurisdiction in the settlement of a claim, dispute or question in connection with this insurance. In the event of any action, claim, or demand by any third party, the liability of the insurers shall be limited to judgments delivered or obtained in the first instance by a court of competent jurisdiction within Barbados.
3. The vehicle described on page 1 of this contract is rented to you in good condition. You will return the vehicle in the same condition, with the same equipment with which it was rented to you. You are responsible for all damages or loss to the vehicle up to the amount of insurance damage/loss deductible shown on page 2&3.
4. You agree that this vehicle will not be used in a manner that represents a violation of this Rental Agreement.
5. Violations of the Rental Agreement include, but are not limited to the following:
  - (a) Allowing an unauthorized driver to drive the vehicle
  - (b) Operating the vehicle while under the influence of drugs or alcohol, regardless of amount or driving in a state of drowsiness.
  - (c) Obtaining the vehicle by giving false information or through misrepresentation
  - (d) Using the vehicle for any illegal or improper purpose.
  - (e) Using the vehicle to push or tow anything.
  - (f) Leaving the vehicle unattended, unless the key is removed, all doors and windows are sealed and locked, and the vehicle is parked in a well lit and safe place. – You will be liable for all damages, loss of use of the vehicle and any charges associated with the vehicle if you violate the Rental Agreement.
6. The Owner will in no event, be liable for any loss of, or damage to, any property left or placed by the Hirer, or any other person, in or on the vehicle or the premises of the owner before, during or after the period of rental. The Hirer will indemnify the Owner against all claims for any such loss or damage.
7. You agree to pay all applicable charges arising from this Agreement including, but not limited to:
  1. All applicable time charges
  2. All costs arising from Parking and Traffic Violations while the vehicle is on rent to you;
  3. Attorney's fees and all costs incurred by us while collecting charges incurred from this Agreement.
8. In the event that you have a flat tyre, our office is to be notified. Repairs to any tyre by you without our specific authorization, may result in you having to replace the tyre.
9. You agree not to make any repairs to our vehicle.
10. In the event of an accident, you agree to notify us immediately and complete an Accident Report Form within twenty-four (24) hours of the accident, unless you are so seriously injured as to be physically unable to do so. You agree to assist us in our investigation of the accident and you agree not to aid or abet any third party in any claims against us arising from the accident.
11. You will at the request and cost of the Owner, do all required by us, and permit your name to be used, by the Owner, for the loss or damage.
12. The Hirer or any other driver of the vehicle will in no event be deemed the agent, servant or employee of the Owner.
13. You agree to return the vehicle on the due back date and time, or upon demand by Thousand Miles Lease & Rental Services, if sooner. Further you agree that we may repossess the vehicle at any time.
14. You, the Hirer will immediately inform us of any loss, damage to or fault in the vehicle and will not use the vehicle while it is in an unroadworthy condition or liable to cause damage to any person or property.
15. Thousand Miles Lease & Rental Services accepts no responsibility for delays in consequence or breakdown or other circumstances.
16. No right of the Owner under this Agreement will be waived except in writing signed by a duly Authorised Representative of the Owner.
17. The Rental Office must approve any additional drivers.
18. The Hirer is responsible for the rental rates, taxes and any other charges payable, the minimum charge is for 24 hours. Early return of an agreed weekly rental converts the rental charge to the daily rate.
19. No eating of foodstuff or drinking of beverages is permitted in the rental vehicle. Smoking is also prohibited in the vehicle. No animals or pets are allowed in the vehicle under any circumstances. Should the upholstery be soiled or burnt by such activities, the Hirer will be liable for all valet and repair costs.
20. The Hirer and any authorized driver must be in possession of a valid driver's license or local visitor's permit. Permits are available through the online link provided by Barbados revenue authority.
21. All traffic offences or violations of parking regulations involving the vehicle during the period of rent, including all fines and penalties will be the responsibility of the Hirer. If the Rental Office has to be pay such fines, the Hirer will reimburse the Rental Office within the 14 days.
